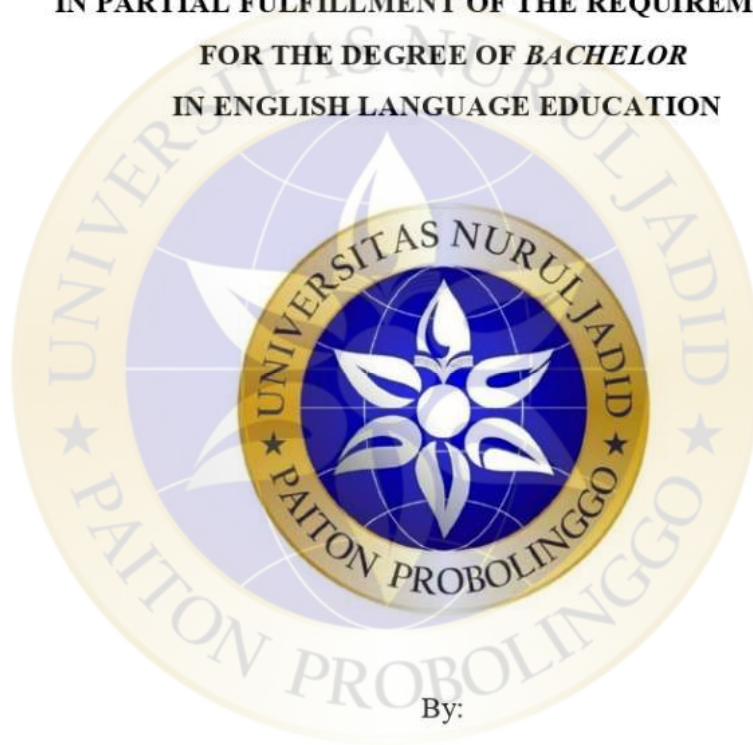

Keywords: Literature, Discourse Analysis, Novel, and Feudal Nobility.

Literature, especially novels, prominently attracts the attention of both students and teachers as literary enthusiasts. On the other hand, understanding the essential content of a novel and critiquing it requires the competence to perform discourse analysis.

This research aims to coherently describe and analyze the simple story constructed, utilizing a psycholinguistic approach diagram to discern the plot structure, and briefly analyze why feudal aristocracy is significant to the feudal society depicted in HAMKA's novel "Under the Protection of Ka'bah."

To achieve the objectives of this research, the researcher employs the Psycholinguistic Approach by John Mandler & Nancy Johnson. The research findings indicate that through its plot, Hamid, the main character in the novel, is portrayed as a poor child with aspirations for higher education. He meets Haji Jafar, a kind-hearted wealthy man who helps him attend school alongside his own child, Zainab. However, Hamid falls in love, and his love remains unfulfilled due to the class differences between them. Secondly, from the discursive analysis, several reasons why feudal aristocracy is important to feudal society are identified.
