

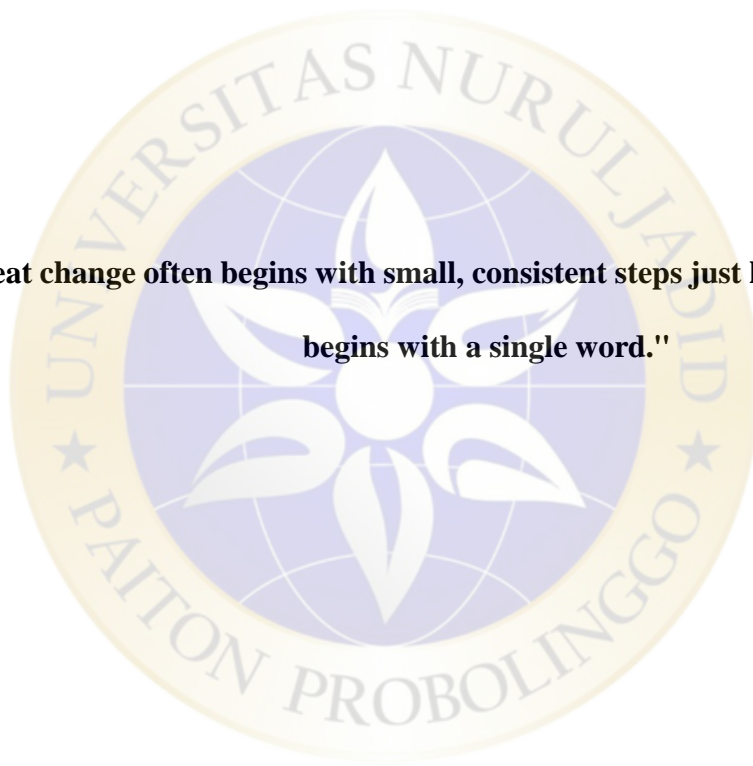

ABSTRACT

Keywords: Student Organization, Grammar Instruction, Instructional Strategies, Instructional Challenges, Daily Communication.

This study investigates the strategies and challenges faced by the NATO student organization in instructing English grammar to enhance students' daily communication at the Foreign Language Development Institute (FLDI), an Islamic boarding school-based language institution. A descriptive qualitative method was employed, involving interviews and observations with four organization members. The findings reveal three key strategies: (1) explicit instruction, using the Focus on Forms approach through direct explanation and structured grammar exercises; (2) implicit instruction, reflecting the Focus on Form approach, where grammar is integrated into communicative activities with corrective feedback provided afterward; and (3) a combined approach, allowing students to engage in language use first, followed by grammar reflection and correction. However, two main challenges were identified: (1) students' low motivation and engagement in grammar learning, and (2) difficulties in applying grammar appropriately during real communication. The study concludes that the integration of Focus on Form and Focus on Forms approaches within a peer-led learning environment holds strong potential, though its effectiveness depends on adequate mentor training, engaging media, and continuous evaluation systems.
